#### *Rules and Regulations:*

1. Bidders must register to receive a numbered bidder's paddle. A \$25.00 refundable deposit is required at the time of registration. (Cash or Check ONLY).
2. Bidders must be able to show proper identification.
3. Bidders must be at least 18 years of age.
4. There is a 13% (3% discount for cash or check) Buyer's Premium in addition to the final bid amount of any item purchased. This premium is due upon check out.
5. All properties are sold "AS IS", "WHERE IS", "WITH ALL FAULTS", "WITH NO WARRANTIES OR GUARANTEES EXPRESSED OR IMPLIED", with respect to the property of correctness of the catalog or other description of physical condition, also, quality, or otherwise.
6. Payment must be made on the day of the purchase. Payment may be made by cash, check, or Visa/Mastercard. All lots are subject to Virginia sales tax unless a resale certificate is presented at the time of registration.
7. All items must be removed within three (3) calendar days of the end of the auction or you will be charged \$5.00 per item, per day unless written authorization is received. Delivery is available. Reasonable rated, priced accordingly.
8. Neither the sellers nor Barrett Street Auction Center are responsible for any accidents incurred during conduction of the auction or during the removal of purchased property. Barrett Street Auction Center will not be responsible for loss or damage to property which is not removed from the premises after the day of the sale. The packing and handling of purchased lots at Barrett Street Auction Center is that of the buyer/purchaser.
9. Barrett Street Auction Center reserves the right to arbitrate and settle any and all disputes.
10. All announcements made at the start of the auction take precedence over all prior statements or advertising.
